6. Accidental Release Measures

Containment In all cases design storage to prevent discharge to storm water.

Emergency procedures If a significant spill occurs:

Engineering Controls

12. Ecological Data

Summary

This mixture is not considered ecotoxic. However, in all cases prevent run-off to drains, sewers and waterways. Do not apply directly to water or to area where surface water is present, or the intertidal areas below the mean highwater mark. Do not contaminate water when cleaning equipment or disposing of equipment wash water or rinsate.

Bacillus mycooides isolate J is a naturally-occurring microorganism commonly found in agricultural settings (i.e., water, soils and plant roots) and is present on fresh produce with no known adverse effects; this is consistent with the lack of adverse effects seen in the submitted toxicological studies. B. mycooides isolate J is not known to produce mammalian toxins of foodborne concern, and no foodborne disease outbreaks associated with B. mycooides or toxin production from B. mycooides in food or feed have been reported.
